# Reference: FOI 543 Freedom of Information request

Thank you for your email, which we received on 2 April 2024. Your request has been handled under the Freedom of Information Act 2000.

## You asked us:

To confirm the number of immigration detainee complainants who received disclosure of documents used by the Prisons and Probation Ombudsman (PPO) as part of investigations into immigration detainee complaints, such as CCTV, body-worn camera footage or use of force reports, between April 2019 and March 2023.

## Our response:

Following a search of our records, the information you requested is not held by us. The reason for this is that the PPO did not disclose any investigation documents to any immigration detainee complainant.

The PPO would provide all immigration detainee complainants with the final output of our investigation, either a letter or report, which sets out the decision we have made and why. This will usually cite the relevant sources of evidence that we have consulted and used to reach the decision, but never the supporting documents themselves.

You have the right to appeal against our response if you think it is incorrect. Details can be found in the 'How to Appeal' section attached at the end of this letter.

#### OFFICIAL

The Prisons and Probation Ombudsman (PPO) carries out **independent investigations** into complaints and deaths in custody. The detailed role and responsibilities of the PPO are set out in our office's Terms of Reference. The PPO has three main duties:

- to **investigate complaints** made by prisoners, young people in detention (prisons and secure training centres), offenders under probation supervision and individuals detained under immigration powers (detained individuals)
- to investigate deaths of prisoners, young people in detention, approved premises' residents and detained individuals due to any cause, including any apparent suicides and natural causes
- to **investigate deaths** of **recently released prisoners** that occur within 14 days of release from prison (except homicide)

The purpose of these investigations is **to understand what happened**, **to correct injustices** and **to identify learning** for the organisations whose actions we oversee so that the PPO makes a significant contribution to safer, fairer custody and offender supervision.

We may use or share your data only to the necessary extent when conducting our independent investigations in the exercise of our official authority. We will share your data with third parties (e.g. the prison) in order to make sure the information is accurate; to prevent or detect failings; and to identify lessons learnt. We may sometimes need to share your data with third parties if required by law. We only keep your personal data for as long as it is needed, as set out in our data retention policy.
