1	The Head of Healthcare should ensure that pathways are in place to provide effective support and referral for prisoners under the care of the mental health team who might be released from court.	Accepted	<p>It is accepted that the mental health team work within the stepped care model and there are differing degrees of supervision / support required depending on where in the stepped care model support is being provided.</p> <p>Service delivery at steps 2 & 3 can include short term support from primary mental health nurses which includes signposting, psychological wellbeing practitioners and health & wellbeing coaches. These services in the community are often accessed via self-referral and do not require referral from a professional.</p> <p>Service delivery at step 4 & 5 includes secondary mental health care and use of the CPA framework.</p> <p>Pathways are in place for the stepped care model to be implemented within the prison and out into the community. 2	<p>The Director and Head of Healthcare should ensure that staff manage prisoners at risk of suicide and self-harm in line with national guidance, including that:</p> <ul style="list-style-type: none"> • ACCT case reviews are multidisciplinary and include all relevant people involved in the prisoner's care, including healthcare staff and those providing through the gate services where relevant; • A case co-ordinator is appointed who attends all ACCT case reviews whenever possible; and • CCT support actions are completed with actions that are specific and meaningful with consideration given to significant upcoming events. 	Accepted	<p>The mental health team have developed a robust process to ensure that initial ACCT reviews are attended by the mental health team. This involves cross referencing the 'daily paperwork' and operational report to ensure that they are aware of all ACCT reviews taking place. The mental health team will establish at the initial ACCT review if further review attendance by the team is necessary. The PSI also states within this point "<i>Healthcare staff should be given sufficient advance notice of this wherever possible. The healthcare representative attending case review(s) should be somebody with knowledge of the prisoner wherever possible.</i>"</p> <p>HMP Forest Bank have named case co-ordinators allocated to those on an open ACCT and they will conduct all case reviews to ensure consistency throughout the process.
