1	The Head of Healthcare should review the treatment policy and management of methadone, including assessing the need for ECG tests when starting methadone and additional monitoring when dosage is significantly increased.	Accepted	<p>The treatment policy was reviewed and updated in February 2020. This clinical policy reflects the changes in the new Orange Book guidelines (Drug Misuse & Dependence - UK guidelines on clinical management 2017) and is predominantly based on the evidence based findings and its recommendations.</p> <p>ECG monitoring will take place according to the policy where methadone is prescribed at a dose of 80mg/day or more, or there is concomitant prescribing of drugs associated with QTc prolongation such as antidepressant and antipsychotic medication, or if there is a history of heart disease or current cardiac symptoms.</p> <p>The policy has been circulated to all prescribers and to the substance misuse clinical team.
