GMMH have a standard operating procedure (SOP) which covers referrals to the psychiatrist. A nursing assessment should occur to identify a need for a psychiatrist review, and this will be escalated through the GMMH weekly SPOA. In addition, internally within GMMH there has been an introduction of a fortnightly clinicians meeting which shares information and sequences treatment for complex individuals.
