Reference: FOI 684 Freedom of Information request

Thank you for your email, which we received on 21 August 2025. Your request has been handled under the Freedom of Information Act 2000.

You asked us:

To provide copies of the following documents, relating to HMP Chelmsford, HM Prison Brixton and HMP Wormwood Scrubs and associated premises, from any stage between 1970 and 1980:

1. Copies of any asbestos surveys identifying or detailing asbestos use within the prison, including details of any asbestos surveys carried out in respect of the prison;
2. Photographs/plans/drawings of the prison, in particular any plans depicting those areas in which asbestos was located in the prison and associated premises;
3. Copies of any notes/minutes/memoranda of meetings in which the asbestos within the prison and associated premises was discussed (in particular, any policies on asbestos management referring to the asbestos containing materials within the prison);
4. Any correspondence with 'asbestos' in the subject line between the owners and any contractors (in particular, any asbestos removal contractors) undertaking work in the prison;
5. Any correspondence with 'asbestos' in the subject line between the prison owners and staff within the office discussing the risks associated with asbestos within the prison;
6. Schedules of any construction work carried out at the prison and associated areas from 1970 until 1980;
7. Copies of any repair and maintenance reports records involving asbestos within the prison and associated areas;
8. Copies of any logs/records relating to asbestos materials within the prison and associated prisons;

9. Copies of any risk assessments relating to asbestos within the prison and associated prisons.

Our response:

The Prisons and Probation Ombudsman (PPO) carries out **independent investigations** into complaints and deaths in custody. The detailed role and responsibilities of the PPO are set out in our office's Terms of Reference. The PPO has three main duties:

- to **investigate complaints** made by prisoners, young people in detention (prisons and secure training centres), offenders under probation supervision and individuals detained under immigration powers (detained individuals)
- to **investigate deaths** of prisoners, young people in detention, approved premises' residents and detained individuals due to any cause, including any apparent suicides and natural causes
- to **investigate deaths of recently released prisoners** that occur within 14 days of release from prison (except homicide)

The purpose of these investigations is **to understand what happened, to correct injustices and to identify learning** for the organisations whose actions we oversee so that the PPO makes a significant contribution to safer, fairer custody and offender supervision.

We may use or share your data only to the necessary extent when conducting our independent investigations in the exercise of our official authority. We will share your data with third parties (e.g. the prison) in order to make sure the information is accurate; to prevent or detect failings; and to identify lessons learnt. We may sometimes need to share your data with third parties if required by law. We only keep your personal data for as long as it is needed, as set out in our data retention policy. If you need any further information about how your data is used, please contact us.

How to Appeal

Internal Review

If you are not satisfied with this response, you have the right to an internal review. The handling of your request will be looked at by someone who was not responsible for the original case, and they will make a decision as to whether we answered your request correctly.
