## Notes

1. The Independent Commission for Reconciliation and Information Recovery (ICRIR) is committed to the highest standards of propriety. Commissioners are expected to exercise their functions with impartiality and integrity, including through the consistent management of any relevant outside interests.
2. This Register of Interests has been compiled in accordance with the ICRIR Declaration and Management of Outside Interests Policy (DMOI Policy).
3. As outlined in Section 4 of the DMOI Policy, all ICRIR Commissioners must adhere to the following key principles:
  - **Integrity of Position:** You must not misuse your official position or information acquired in the course of your ICRIR duties to further your private interests or those of others.
  - **Honesty and Impartiality:** You must be honest and impartial in the exercise of your duties and must not allow your judgement or integrity to be compromised.
  - **Responsibility to Declare:** It is your responsibility to declare all relevant outside interests as soon as possible. Where a conflict (actual, potential, or perceived) arises, immediate steps must be taken to address it.
4. The DMOI Policy sets out the following actions for managing relevant outside interests:
  - A. Declarations of interests that could reasonably be perceived to affect a Commissioner's ability to perform their duties must be recorded in the Register of Interests. This includes relevant employment or significant financial interests of close family members where a potential or perceived conflict might arise.
  - B. Some interests may not be published in the Register where the potential for perceived conflict is sufficiently remote. In such cases, internal awareness by ICRIR is deemed sufficient and proportionate to the personal nature of the data.
  - C. Commissioners should consult the ICRIR Chief of Staff before accepting any new appointments.
  - D. Commissioners must inform the ICRIR Chief of Staff of any changes to their personal interests and formally review their declaration annually.
  - E. The Register of Interests is reviewed annually by the ICRIR Audit and Risk Committee to ensure that outside interests do not impact a Commissioner's ability to perform their duties.
5. Declaring an interest in the Register does not remove the obligation to declare any relevant interests—whether registrable or not—at Board or sub-committee meetings where relevant business is being conducted.

6. The following headings provide the framework for publication of interests:

- **A. Positions of Employment** – All other remunerated employment positions, whether relevant or not.
- **B. Other Remunerated Positions** – Any other compensated roles, such as public office.
- **C. Voluntary Positions** – Non-remunerated roles that could reasonably be perceived as relevant to the Commissioner's role.
- **D. Shareholdings Over 5%** – Shareholdings in companies that have a contract or arrangement with ICRIR.
- **E. Interests of Family Members** – Relevant financial interests or positions held by close family members that could conflict with the Commissioner's role.
- **F. Other Relevant Interests** – Any other interests that could reasonably give rise to a perception of conflict and where publication is appropriate to mitigate that perception.

7. This Register of Interests was last updated in **September 2025**.
