## Non-means tested funding

**Q: Surely all children's cases should be dealt with as non-means tested?**

**A:** The term 'non-means tested' only relates to specific proceedings, as set out by legislation. If a youth is facing one of those proceedings the application will be non-means tested. However, criminal proceedings under Regulation 14 of the Legal Aid, Sentencing and Punishment of Offenders Act 2012 are means tested, unless deemed otherwise. Therefore, youths are means tested, but are always deemed to be eligible and passported due to their age.
