### THIRD WITNESS STATEMENT OF AMISSÃO CALOCANE

---

I Amissão Calocane, will say as follows:-

1. I make this statement in response to a Rule 9 request sent to my solicitor on 28 May 2026 and further to my first witness statement [WITN0086001] and second witness statement [WITN0086004].
2. This statement is based on my knowledge and beliefs. Where any information is not from my own knowledge or belief, I make that clear below. I reserve the right to amend this statement if further documents become available.

#### **Valdo's visits to Wales in July and August 2021**

3. Valdo came to Wales in July 2021 and in August 2021. I do not remember the exact dates.
4. I cannot remember lots of details about these two occasions but I have provided as much information as I can remember.
5. When Valdo came in July 2021, both Celeste and I were there. I remember that Valdo was calm but he stayed in his car and did not want to come into the house even though we had asked him to. I do not know exactly why he didn't want to come in but I remember him talking about the State, monitoring and security.

6. I was concerned about Valdo not wanting to come into the house and the things that he was saying. However, I didn't do anything in response to him coming to Wales as what he was saying was nothing new so I did not think there was anything new to report. It had been an ongoing issue and I knew Valdo was being looked after by mental health services who knew that he had these thoughts.
7. I do not remember if I spoke to Celeste and Elias about Valdo coming to the house in July and if so, what we spoke about. I think I would have spoken to them as Celeste was there and we also spoke often as a family about Valdo and our worries about him.
8. When Valdo came to Wales in August 2021, Celeste was away. Valdo must have rung me from the car and said he had come to visit. As he had done in July, he stayed in the car and did not want to come into the house. I do not have any memory of what we talked about.
9. I do not remember if I was specifically concerned about Valdo on that occasion. I do remember being generally concerned about him around that time but I didn't do anything in response as I didn't think there was anything new to report, as I explained in paragraph 6 above.
10. I do not remember if I told Celeste or Elias immediately that Valdo had come to Wales. I may have told Celeste over the phone but I cannot remember. I think I would have told them at some point afterwards as we would talk about Valdo.

### **Work at the oil refinery**

11. I cannot remember the dates that Valdo worked at the oil refinery with me. I think it could have been in 2011 or 2012 but I am not sure.
12. I worked at the oil refinery for around 3 years. Valdo worked there during some of the shutdown periods. Shutdown periods are periods of time that an oil refinery has to shut in order to carry out essential maintenance. During the shutdown periods, there are a number of tasks such as changing and cleaning

equipment, replacing equipment, and cleaning the environment. As far as I remember, Valdo's role was mainly cleaning but I believe there were times when he would assist the operators with changing equipment and taking it away.

13. Valdo did not have any issues when he worked at the refinery. I did not observe any unusual behaviour from him when he was working there. On the contrary, he was hardworking, people liked him, and I remember other people who worked there telling me at the time how hard he worked.
